



## GREATER MIAMI USBC BOWLING ASSOCIATION Hall of Fame Criteria

1. The Hall of Fame shall be divided into three (3) categories:
  - A) Bowling Ability
  - B) Bowling Service
  - C) Honorary
2. Nominations for the Hall of Fame (HOF) will be accepted with an application before March 30th. Nominations can be made by anyone, including self-nomination. If a category is not indicated on the nomination, the Vetting Committee will decide which category would be appropriate, with the understanding that a person could be nominated in both Ability and Service.
3. When an application is received, the applicant will be notified. The HOF Vetting Committee will meet to review the applications by April 30. Applicants who are moving forward in the selection process will be given until May 15 to provide any supplemental information. Those submitting the application will be notified if the nominee will be sent forward to the Selection Committee or returned due to non-selection.
4. The Chairperson will compile the applications and distribute them, on or before June 30<sup>th</sup>, to the current members of the Hall of Fame who have elected to participate in the selection process.
5.
  - 1) The Hall of Fame members, who elect to participate, will meet no later than July 31<sup>st</sup> to review, discuss, and vote on the eligible nominees.
  - 2) For this to be a legal meeting and election, a quorum of eight (8) Hall of Fame members must be present.
  - 3) Mail in or E-mail ballots will be accepted by Hall of Fame members who have elected to participate, but are unable to personally attend the meeting. The ballot or e-mails must be received/post marked two (2) weeks prior to the day scheduled for the meeting, in order to be accepted.
  - 4) Voting shall be on a one (1) ballot system. If a nominee receives 50% +1 of the votes cast, said nominee is deemed to be elected.
  - 5) The ballot provided shall contain the names of each nominee, grouped according to the category under which each is seeking election.
6. **BOWLING ABILITY CRITERIA:**
  - 1) The Nominee will be judged on his/her bowling ability while a member of the Greater Miami USBC Association, GMWBA, or GMBA. Youth bowling activities are not included.
  - 2) The Nominee must have been active in the Greater Miami area for a minimum of ten (10) years, nonconsecutive.
  - 3) The Nominee must be considered on his/her **individual** achievements. State and nationally sanctioned events, while a member of the GMUSBC, may be considered as additional information.
  - 4) The Nominee must have participated in a minimum of five (5) local association city tournaments.
  - 5) The nominee must have demonstrated a history of good sportsmanship.

7. BOWLING SERVICE CRITERIA:

- 1) The nomination will be based upon Service as a member of the Greater Miami USBC Association, GMWBA, GMBA, or GMJBA.
- 2) The Nominee must have been active in the Greater Miami area for a minimum of ten (10) years, nonconsecutive.
- 3) The Nominee shall be of good ethical character and shall have demonstrated an unselfish commitment to the sport of bowling.
- 4) While service to our sport is appreciated, this honor is intended to include those who provide exceptional, not merely participatory service and, likewise, excludes services provided by owners and employees of bowling establishments who contribute only as part of their employment. Exceptional and innovative service, above and beyond mere participation or employment, is the basis for this award.

8. HONORARY CATEGORY:

- 1) Election by the committee for this category shall be judged by the Nominee's present and/or past activities, in support of GMUSBC, GMWBA, GMBA, or GMJBA.
- 2) A nominee previously nominated, but not elected in the Ability or Service category, is not eligible for consideration in the Honorary category.
