Sanctioned Youth bowlers who are 10 years & older are welcome to participate. Youth will bowl in their own division. Boys and Girls will compete with each other. Scholarship funds rather than cash will be awarded.

Rules of Tournament Play:

1. Prize money portion of entry fee will be returned 100% within each division with 1 out of 4 entries cashing. Separate prize fund for Men, Women & Youth (Youth will have 1 winner). **Youth prize winnings will be given in the form of SMART scholarship funds.**
2. USBC Sanction # 04275
3. Men & Women handicap ratio is 100% of 230. Youth handicap ratio is 100% of 210.
4. This tournament will be a 3-game singles handicap event based on highest 2023-2024 yearbook average including summer.
5. If a bowler does not have a yearbook average, they must show proof of a 21 game 2024 summer league average or a current league average of 21 games, or if none of the above, a 21-game league average from the 2022-23 season. All others will be required to bowl scratch. Rule 319c-Average Adjustments does apply. The Ten Pin rule, and reporting of prize money, do not apply.
6. Bowlers will bowl 3 games: total pins, plus handicap will determine winners. If there is a tie for first place, the 1st & 2nd place prize fund will be divided equally.
7. Any rules not covered by the above shall be governed by the USBC Rules and Bylaws.
